#### **ORGANISING AUTHORITY**

The Regatta is organised by Regattas Asia in conjunction with the Samui Yacht Club Regatta, under the auspices of the Yacht Racing Association of Thailand and the Sports Authority of Thailand.

#### 1. Rules

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS)
- 1.2 Appendix T (Arbitration) may be used for protests alleging a breach of the rules of Part 2, 4 or Rule 31. The arbitration process will be detailed in full in the sailing instructions.

## 2. Advertising

2.1 Advertising will be permitted in accordance with World Sailing Regulations. The hull and the blunt bow is reserved by the regatta organising committee for display of advertising by event sponsor(s).

# 3. Eligibility and Entry

3.1 The regatta is open to all boats of the Optimist Class, Laser Class, 420 Class, Far East 11 Class.

The courses to be sailed may consist of Windward/Leeward or Triangular courses as described in the

Sailing Instructions..

10. Scoring

10.1 A maximum of six (6) races for All Fleet . A minimum of 2 completed races is required to

constitute a series.

10.2 When less than 5 races are completed a boat's series score shall be the sum of all races.

10.3 When 5 or more races are completed a boat's series score shall be the sum of all race scores

excluding her worst result.

11. Penalty System

Arbitration may be used for protests alleging a breach of the rules of Part 2, 4 or Rule 31. The

arbitration process will be detailed in full in the sailing instructions.

12. Prizes
